

The Maltese government aims to bring the maritime sector back in the spotlight of the EU agenda during its 6 months
Presidency of the EU Council. As an island nation and a shipping power, Malta aspires to use next semester and the EU Maritime Year to create momentum for big a leap concerning the EU maritime legislation and policy.

Thus, the Maltese Presidency expects to finalize the approbation of the Passenger Safety Package, the Directive on the recognition of professional qualifications in inland navigation and especially to boost the coordination work that the EU has carried out with IMO during the last years. The EU presents its Strategy on International Ocean Governance

The EC and the EU's High Representative presented a Joint Communication on International Ocean Governance. The publication proposes ways the EU cant step up and play a stronger role at global and regional level shaping the way oceans are managed and used. The document sets out detailed actions in three priority areas: Improving the international ocean governance framework, Reducing human pressures on the oceans and Strengthening international ocean research and data. The European Parliament decides on the Port Access Regulation and Shiping Emissions

The last Plenary of the European Parliament adopted the Port Access Regulation. Albeit towage being still part of the services that are regulated, the compromises between the EU Council and Parliament have made our position somewhat bette. Moreover, the EP Environment committee decided to include shipping emissions within the framework of the European ETS revision. The text agreed would force the EU to develop its own emission reduction plan by 2023 if IMO failed to deliver a global deal by 2021. The Plenary will vote this dossier in February.



Rimorchiatori Napoletani hosts Sea Traffic Management Validation Project Event

ETA member, Remorchiatori Napoletani organized an event which aimed at demonstrating the EU project findings. STM Validation´ objective is to analyse and validate in large-scale test beds in both the Nordic and Mediterranean Seas, encompassing around 300 vessels, 13 ports and 5 shore based service centres as well as using the European Maritime Simulator Network.
