EUROPEAN TUGOWNERS ASSOCIATION MEMBERSHIP TERMS & CONDITIONS

The **EUROPEAN TUGOWNERS ASSOCIATION (ETA)** is a not for profit organisation with the intention of safeguarding the interests of its Members in all matters that are of relevance to the European Towage Industry.

Membership of the ETA is open to all persons satisfying the requisites of the ETA's Statute against payment of the relevant Membership Fee.

The following terms & conditions are applicable in respect of persons registering for Membership with the ETA -

- 1. **Subscription to the ETA Statute** Each person admissible as a Member of the ETA in terms of its Statute shall subscribe to the said Statute and be bound by the provisions thereof, as the same may be amended from time to time.
- 2. **Membership Fee** Each approved Member (except Honorary and Affiliate Members) shall be bound to pay an annual Membership Fee as communicated to him from time to time.
- 3. **Designated Person** Each approved Member shall nominate a designated person/s to receive correspondence from and communicate with representatives of the ETA from time to time on its behalf. The identity of such designated person/s, and of any changes therein as well as any details relating thereto, shall be clearly and promptly communicated by the approved Member to the Secretary General of the ETA.

Each approved Member shall likewise nominate a designated person/s to whom invoices relative to Membership Fees or any other dues should be dispatched. The said designated person/s may be the same as those referred to above. The identity of such designated person/s, and of any changes therein as well as any details relating thereto, shall be clearly and promptly communicated by the approved Member to the Secretary General of the ETA.

Failure to notify the Secretary General as per above shall not affect the approved Member's liability and responsibility under this Condition.

- 4. **Sponsorships** Any approved Full or Associate Member participating in Sponsored Events shall be bound to settle any sponsorship contributions on such terms and conditions as may be agreed to from time to time with the ETA and the sponsored entity, as may be applicable.
- 5. **Resignation** In the event that the approved Member intends to resign from Member of the ETA, then such Member shall be bound to send a notice in writing of his intention and submit such notice by registered letter or by email against confirmation of receipt to

the Secretary General of the ETA. Any such notice may only be given at least three months prior to the end of the relevant Financial Year. Membership will cease upon the expiry of the period of notice. Notwithstanding such resignation, in the case of Full and/or Associate Members, the Member is bound to honour payment of the Membership fees and contributions or debts, payable up to the time of the resignation, to the ETA. Invoices will be sent at the last known address. In this respect, it is incumbent upon each Member to advise the ETA of any change of address.

The above terms and conditions are without prejudice to the provisions of the Statute of the ETA which shall apply accordingly. They are moreover binding upon and inure to the benefit of the ETA and the approved Member.
