### ETA produced new videos that cover its history and present



# The EU co-legislators give the final green light to key legislation on shipping emissions

The European co-legislators, the EU Parliament and the Council adopted two new laws that will be essential to decarbonise the maritime sector. These are the **FuelEU Maritime Regulation** and the **Alternative Fuels Infrastructure Regulation (AFIR)**.

The first one establishes a mandatory carbon intensity reduction goal for the sector, which should go from a 2% reduction in 2025 to as much as 80% by 2050. In principle, this Regulation will not cover the port towage sector as these rules only apply to ships

over 5000GT, but the EU Commission will review the rules by 2028 in order to decide whether to extend emissioncutting requirements to smaller ships like tugboats. The regulation includes as well the following measures:

- A special incentive regime to support the uptake of the so-called renewable fuels of non biological origin (RFNBO) with a high decarbonisation potential.
- An obligation for passenger ships and containers to use on-shore power supply for all electricity needs while moored at the quayside in major EU ports as of 2030, with a view to mitigating air pollution in ports, which are often close to densely populated areas.
- Revenues generated from the regulation's implementation ('FuelEU penalties') should be used for projects in support of the maritime sector's decarbonisation.

Concerning AFIR, it requires seaports hosting at least 50 calls of large passenger ships or 100 calls of container ships per year to provide shore-side electricity infrastructure by 2030. EU countries will also now be required to report their plans for green bunkering points, including electricity, hydrogen, methanol and ammonia refuelling infrastructure in their ports.
