## **Speakers:**

Alberto Dellepiane started his career in 1992 in the maritime business as chartering manager's assistant at K.M.E., broker at Offshore Shipbrokers and then in Banchero Costa. From 1996 till 2001 he worked as Procuring Manager at Terminal Rinfuse Genova managing an ambitious investment plan in new industrial plants that led the company to a peak 2 million tons dry bulk handled. In 2002 he joined his family company Rimorchiatori Riuniti contributing to the restructuring of the harbour towage business with particular focus on the labour organization. Currently, he is CEO of Rimorchiatori Riuniti Porto di Genova, Rimorchiatori Salerno and of S.E.R.S., Director of Rimorchiatori Augusta, Rimorchiatori Mediterranei and Chairman of Tripmare.

**Nick Price** is a Senior Shipbroker at Century Marine Services Ltd with over a decade of experience in shipbroking and vessel valuation, specialising in tugs, workboats and barges. Prior to Century Marine, Nick Studied Law at the University of Kent and began his shipbroking career as a Towage and Salvage broker with Samuel Stewart and Co in Blackheath. Nick is also a Fellow of the Institute of Chartered Shipbrokers.

**Luis Núñez** is currently the Manager of European Affairs of the Algeciras Bay Port Authority. He is a civil engineer and has several specialized master's degrees in logistics, among other academic backgrounds. With 15 years of experience, he has participated in various international projects such as the Haramain High Speed Railway in Saudi Arabia and HS2 in the United Kingdom, among others. In the last 4 years he has worked on the European directives of FIT FOR 55 to apply new technologies and regulations in the Port of Algeciras, to reduce GHG emissions derived from maritime port activity.

**Alberto Rossi** is since 2018 the secretary general of Assarmatori, an Italian shipowners' association representing both national and international shipowners and ship operators which, regardless of their flag State, work within the Italian maritime cluster.
